

#### **Experience**

- In accordance with arguments, the Appellate Division of the New York Supreme Court reversed a lower court's order and reinstated plaintiff's Labor Law and negligence claims, finding that the lower court's award of summary judgment in favor of a large-scale construction company and dismissal of plaintiff's complaint in this personal injury action was premature. The plaintiff was afforded a reasonable opportunity to conduct discovery.
- Following an appeal, secured summary judgment in favor of contractor client in a personal injury
  matter where the contractor submitted evidence that it owed no duty of care to the plaintiff and
  there were no issues of fact as to whether the contractor, in the performance of work, launched a
  force or instrument of harm leading to the alleged injury.
- In a breach of contract suit, obtained reversal of a lower court's denial of the motion to disqualify the plaintiff's counsel pursuant to the advocate-witness rules. In this regard, the Appellate Division of the New York Supreme Court accepted arguments that plaintiff's attorney was the only individual with knowledge of the underlying transaction, which forms the basis of the breach of contract suit and, therefore, he is "likely to be a witness on a significant issue of fact."
